DIVE INTO FRENCH LUXURY & LIFESTYLE

Decision-making and managerial skills are affected by cultural differences, often in subtle ways. Based on the **specificities of French culture**, the participants will identify and manage cultural situations with kindness and tolerance, allowing them to understand the **interactions between cultural differences** and the workplace.

The participants will also discover the characteristics of the French style through the **wine, jewelry, perfume, and luxury industry markets**.

DISCOVER SUSTAINABLE BUSINESS IN EUROPE

Europe is **full of business opportunities**. The course will not only provide an insight of business practices within the European area but will also help students to think "out of the box" and imagine **new management practices**, especially those that foster the principles of responsible management.

PROGRAMME DATES

The MBS Summer School runs from June 17 to July 11, 2024. Before the programme starts, the enrolled students will receive a detailed schedule by email.

The 4-week programme consists of approximately 80 contact hours (20 hours per module), corresponding to 12 ECTS credits.

Participants can enroll for the full four weeks or for two consecutive weeks corresponding to a block of 2 consecutive modules (Block 1 or Block 2) :

CERTIFICATE OF COMPLETION & RECORD OF GRADES

At the end of their programme, the participants will receive, in person, a Certificate of Completion.

A Record of grades, mentioning the courses taken by the participant, the ECTS credit value of each course and the mark/grade points obtained, will be sent by email approximately one month after the end of the programme, to the address requested by the student.

Students requesting that a record of grades is sent by express airmail will be charged 25€ for each transcript sent.

Transfer of credits is at the discretion of your home institution. We strongly advise you to get approval from your home university in advance if you wish to add these credits in your study plan.

WHAT'S INCLUDED IN THE PROGRAMME FEE

- Tuition for a total of 6 to 12 ECTS credits, depending on the duration of the programme (2 weeks or 4 weeks)
- Company visits
- Pick up and transfer to the accommodation upon arrival
- Tramway/Bus travel card within the city (for 2 or 4 weeks)
- Montpellier city tour
- Welcome coffee
- Farewell cocktail/dinner
- Certificate of completion (delivery subject to minimum class attendance of 80%)
- Record of grades

CANCELLATION POLICY

The programme fees are **non-refundable** under any circumstances, unless the programme is not offered due to a lack of participants or in case of "Force majeure".

In the unlikely event that Montpellier Business School is closed in June/July 2024 due to the pandemic and/or the World Health Organization officially recommends the application of travel restrictions to France during the months of June/July 2024, enrolled participants would receive a **full refund of the programme fees**.

Please note that, in the event of programme cancellation, **MBS cannot be held responsible for any travel, visa and/or any other expenses that prospective participants may have paid for** before or after programme cancellation.

It is the sole responsibility of participants to apply for and obtain their visa (if applicable) in a timely manner. Rejection of visa application or late visa delivery of visa are not eligible for refund.

WITHDRAWAL POLICY

The participants can use their right of withdrawal within 14 calendar days of notification of their admission into the programme by MBS.

HOW TO APPLY

WHO CAN APPLY

Undergraduate / Bachelor students from any academic background, or recent graduate with less than two years of work experience, are welcome to apply to MBS Summer School (100% taught in English).

APPLICATION & ENROLLMENT DEADLINES

As the number of slots are limited, we recommend that you apply as early as possible.

- **EARLY BIRD REGISTRATION DEADLINE** (only for non-partner universities students applying to the 4-week programme)

Application deadline: **March 22nd, 2024.**

Applying during the Early Bird phase is strongly recommended for **students who need a visa to enter France.**

If you are admitted in the 4-week programme as an Early Bird applicant and in order to secure your slot, you shall make a full payment of the programme fee and provide us with a **proof of payment before March 31st, 2024.**

Failure to do so will automatically cancel your admission without prior notice and free up your slot for another candidate.

- **STANDARD REGISTRATION DEADLINE**

Application deadline: **April 30, 2024.**

If you are admitted as a Standard phase applicant and in order to secure your slot, you shall make a full payment of the programme fee and provide us with a proof of payment **within 7 calendar days after the date of admission into the programme.**

Failure to do so will automatically cancel your admission without prior notice and free up your slot for another candidate.

ADMISSION REQUIREMENTS & PROCESS

If you wish to apply for Montpellier Business School Summer 2024 programme, you must fill in and submit an **online application form**. Before you start your online registration, make sure that you have a scanned version or the **following documents** that you will have to upload before submitting your application :

- **Curriculum Vitae** in English
- **Motivation letter** in English
- **Transcript of records for the current year** if available, or a screenshot of your home university personal student area
- **Certificate of University Enrollment** (or Certificate of Company Employment, if applicable) - duly signed and stamped - issued by your Home University (or Company, if applicable) in the past 30 days
- **Photograph** with blank background (jpeg 100ko max. 90x116)
- **Proof of English proficiency**, including TOEIC, TOEFL, IELTS, Duolingo, Cambridge Certificates, among others (if you are not a native English speaker), or a letter from your home university certifying that you achieved at least a B2 level in English

Within approximately 5 working days after the submission of your application, we will inform you of the decision of our admission board, which is based on the provided documents (academic background and performance, English proficiency, motivation).
